Ed Crone, Grand Gateway, addressed the BOCC regarding the Solid Waste Exploratory Committee. Crone stated there would be a meeting held Wednesday, November 16 to set locations of proposed manned centers, to explore funding needed to operate them, to establish policies regarding operation and the hiring of a bookkeeper to manage not only books but to outline other duties of that position. He said their goal is to create a possible plan for these centers to be fully operational within 5 years.

Mike Major stated the SWTA were asked to return the green dumpsters to locations at February 2016 levels, which did not happen. Major said they will continue to ask. As of today he believes the Trust Authority is violating not only open meeting laws in regard to changing scheduled meetings but also violating the fact of not having a 2015 audit on file. Major stated he would be e-mailing Mr. Crone and any commissioner who requested it a recommendation that he feels will satisfy 90% of the County with a savings in cost.

Commissioner Smith announced that tomorrow he is going to an ODOT Meeting in District #8 (Tulsa). It is a pre-construction meeting regarding the Whitewater Bridge. He stated the public would see equipment arriving and work should begin in the next few days.
