Commissioner Martin stated that the Contract between the OSU Extension Office and the Board of County Commissioners dated July 1, 2017 to June 30, 2018 that was approved at the July 17, 2017 Commissioners Meeting, had been budgeted \$10,000.00 short.

Assistant District Attorney Lelecas stated he would need to discuss and review the contract with Bill Turner, of Turner & Associates, PLC.

Gus Holland with the OSU Extension Office stated the contract was legal and binding and that the budget was signed and approved \$10,000.00 short. They needed additional funds to make payroll thru the end of the fiscal year. Holland discussed all the services they do for the County including Youth Development, 4H, Ag & SDS. Holland also stated they will be asking for additional \$10,000.00 per year for the next four years to raise their budget.

Commissioner Martin discussed the use of monies in the Use Tax and 20D Accounts. He discussed how the funds are used for insurance deductibles and courthouse repairs. They have to be kept available to keep the jail in compliance and offices running in case of a catastrophic event.

Commissioner Poindexter asked what the additional money would be used for.

Holland stated it would be used to pay OSU Staff.

NE District Program Specialist, Nancy Johnson stated they needed the funds for salaries and payroll, but programs will still be offered as long as the educators are here.

Commissioner Martin stated this was for discussion only and there will be no action until the following Monday.
