Martin asked if another transfer of this type will be needed. "We probably will," Barnes said. The commissioners discussed projects they will be paying off soon and others they will be starting. AGENDA #11- Item was not needed as David Morris was not present to deliver Solid Waste Trust Authority report.

AGENDA #12- A motion was made by Commissioner Martin and seconded by Commissioner Kirk to hear a report presented by Vicki Cossairt, Human Resources Director, concerning all current issues in the Human Resource Department with discussion and action required.

Cossairt said the commissioners needed to approve the updated drug and alcohol policy for the county pursuant to new law taking effect Nov. 1. She said the law requires a 30-day notice be given to employees to make any change in policy. The change includes the new medical marijuana law and safety sensitive positions. Cossairt is making a list of employees in safety sensitive positions. They will be put on a random drug testing list. She said the list will include road department drivers, sheriff's employees, dispatchers, custodian, Emergency Management and anyone driving more than 50 percent of their work time. Everyone who drives to make appraisals will be put on the list.

Cossairt said policies concerning reporting sexual harassment and limited English must be adopted in order for the Sheriff's Office to receive federal grants. Sexual harassment can be reported to Human Resources, the

Cossairt discussed the retirement status of the Election Board Secretary, who is appointed. The Oklahoma Public Employees Retirement System only recognizes elected and non-elected employee distinctions. Both the State Auditor and District Attorney agree the Election Board Secretary should be classified as an elected official. If a person working in the office is appointed secretary, their accumulated compensation time and vacation time should be paid out. As an elected official, the Election Board Secretary will not accrue vacation and sick time.

"She needs to be classified one way or the other to get due rights of retirement," Cossairt said. The county provides a yearly Health Savings Account in the amount of \$1,000. At present, employees must work a full year to receive this benefit. "It appears we have hired people with long-term intent to stay," Cossairt said. She proposed that when an employee has worked a full year, they receive the \$1,000, and also receive \$1,000 on January 1, even if those two dates are close together. Martin asked about the county turnover rate. Cossairt said she will be him some numbers.

"The turnover rate will dictate how we handle the HSA," Martin said.

"What I need is for you to approve the \$1,000 as before today," Cossairt said.

Once a year employees are able to change or add to their insurance. Cossairt said American Fidelity Insurance will be in the county Sept. 30 and Oct. 4 for the enrollment period. Cossairt said the representative will visit each county barn, the Sheriff's administration office and set up in the office by the commissioners' meeting room. She said three new health insurance options will be offered to retirees at around \$100 per month each.

Cossairt said for employees choosing to pay the difference between the high deductible insurance and the lower deductible one, each employee will pay approximately \$190. She asked commissioners to approve this rounded-off amount.

County Assessor Larena Ellis-Cook came in late, so Cossairt recapped her presentation. Ellis-Cook made the requisite number of elected officials for a quorum to vote on approving policies.

Martin made a motion to approve the drug policy update and list of drivers. The motion was seconded by Martin Kirk. All elected officials present, Poindexter, Martin, Kirk, Barnes and Ellis-Cook voted yes. A motion was made by Martin and seconded by Kirk to approve procedures for reporting harassment. The motion was seconded by Martin Kirk. All elected officials present, Poindexter, Martin, Kirk, Barnes and Ellis-Cook voted yes.

A motion was made by Martin and seconded by Kirk to approve the procedures for limited English speakers. The motion was seconded by Martin Kirk. All elected officials present, Poindexter, Martin, Kirk, Barnes and Ellis-Cook voted yes.

A motion was made by Martin and seconded by Kirk to approve classifying the Election Board Secretary as an elected official for purposes of retirement.

A motion was made by Kirk and seconded by Martin to approve the Health Savings Accounts for \$1,000 to be distributed Jan. 1, 2020. The motion was seconded by Martin Kirk. All elected officials present, Poindexter, Martin, Kirk, Barnes and Ellis-Cook voted yes.
