

DELAWARE COUNTY COMMISSIONER MEETING MINUTES

September 5, 2023

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on September 5, 2023. The agenda was posted August 31, 2023, at 4:17 p.m. and placed in the kiosk on the courthouse lawn well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member. County Clerk Barbara Barnes was absent. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. Barnes was absent.

AGENDA #6 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck for approval of citizen's participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There were none.

AGENDA #7 -A motion was made by Commissioners Callihan and seconded by Commissioner Beck to hear report by Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Cossairt said the county had 135 employees Tuesday. Since her last report, nine hires have been made, four employees have terminated, and one offer has been declined. She said one new captain begins at the Sheriff's Office today. Cossairt said all the job openings are getting filled.

Cossairt said she will be sending the new state travel policy to the elected officers soon. She said the state policy will be the county's policy and she got it from the state's website.

Cossairt said Dr. Pommel who did the county's DOT physicals is retiring. She is negotiating with a new provider who will soon be certified to give the tests.

Cossairt said this is the flu and Covid vaccination time of year, and she encouraged everyone to get the shots, wash their hands often and keep their distance from other people.

Cossairt said the option period for insurance enrollment will be open Oct. 2. A representative of American Fidelity will be here for consultations.

AGENDA #8- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There was none.

One bid was received from Firemaster on a 2024 truck for \$339,000 with financing at Welch State Bank. Fire Chief Vince Osburn took the bid under advisement.

AGENDA #15- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible acceptance bids for a ¾ ton truck for District #1. Co. Bid #2324/04. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #16- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action bids for the new phone system for the Delaware County Courthouse, Annex and Sheriff's Office. Co. Bid #23-24/03. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Representatives from both companies, BOLT and TeleComp were present. Poindexter asked if there will be training for system users. Bodine said there will be in person training. "And we are close, so we can come back any time," Bodine said. Poindexter asked what happens if the phone lines go down. Bodine said hopefully that will never happen, but there is still some fiber redundancy. Saddler said the internal phones will keep functioning and calls can be forwarded to cell phones. Bodine said BOLT phones will also still work internally. Poindexter said he thinks one copper line should be maintained.

Poindexter asked about service calls - if the charge is by the hour.

Bodine said service calls are covered in the BOLT contract monthly charge which is \$299. She said if the county would rather pay by the hour, the rate is \$175 per hour. Saddler said TeleComp service is done 95 percent remotely. He said it would be a rarity to send a person here.

Both companies will answer calls on a phone tree, but BOLT will retain the current phone numbers. TeleComp will have to change the courthouse phone number. Saddler said TeleComp is a cloud-based phone system. Bodine said BOLT's system runs on fiber optic lines and Grand Telephone will work with BOLT to keep the county's phone numbers. The county numbers are pulled out and put into BOLT's fiber optic system. They will no longer be in the old copper lines. Bodine said the bills from Grand Telephone will decrease a great deal. The Sheriff said he cannot afford to pay another phone bill just to keep the same number.

Bodine said the system proposed for the courthouse was set up in Jay Schools two or three years ago and it has worked well.

Both reps said extensions may be set up under names or numbers – or by any identification desired. Saddler said TeleComp can do all the administration under the contract. He said the County Clerk's Office generally handles all the changes. Both companies have a dot com support ticket system.

Saddler said the elevator must remain on a hard wire copper line.

In the TeleComp bid, phones are leased to the county. The monthly bill pays for the county running on TeleComp's internet system. In the BOLT quote, the county is buying equipment and will own it outright with a one-year warranty. Saddler said TeleComp will also sell the county the phones, but that is not the main cost, the licenses are.

Commissioner Beck asked how long it takes to repair a fiber optic cable that is cut. Bodine said it depends on how badly the wire is cut, but it can be repaired in a matter of hours.

BOLT will use existing fiber optic lines and each office will be a stand-alone system.

Saddler said TeleComp has a mobile app to send everyone's calls to their cell phones if the system goes down. Bodine said while BOLT does not have an application, they can also route calls to cell phones.

Callihan said he wants to see how much the county pays for phone bills now. Bodine said she can get this information. Saddler said there will be one new number for Delaware County, it will be changed, then all other offices will branch off of that. The Sheriff asked about long distance. The TeleComp system long distance is free. BOLT has to charge for long distance because it will still be affiliated with Grand Telephone.

AGENDA #17- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action contract between the Sheriff's Office and Techfive for email services. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

The Sheriff said the current email provider to his office is discontinuing email service. He said he would like to switch to the company who does the Sheriff's Office IT now. He said the price is about \$6 for each user and they will be able to maintain their current addresses. There are about 70 addresses. The Sheriff said AppLink will stop service Oct. 12. The sheriff will try to have a contract to present to the commissioners for the next meeting's agenda.

AGENDA #18- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action accepting a donation from Cherokee Nation in the amount of \$10,000. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. The sheriff said the donation is for no specific purpose and is to be used at his discretion. A motion was made by Callihan and seconded by Beck to accept the donation. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #19- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to approve advertisement for bids to purchase a new pumper truck for the Kansas Volunteer Fire Department. Bids will be received no later than 10/5/23 at 4 p.m. in the County Clerk's Office, Jay, Okla. Bids will be opened and reviewed in regular meeting dated 10/10/23 at 9 a.m. Board reserves the right to accept/reject any or all bids and the right to re-advertise. Bid #23-24/07. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.
