AGENDA #5 - A motion was made by Steve Odle and seconded by Charles Marts to review/approve estimate of needs and request for appropriations for EMS, cities, towns, schools, and various other county entities, which included the following: Monkey Island Fire Protection District, Cleora Emergency Medical Service Board, Grove Emergency Medical Board, Cleora Public Schools, Oaks-Mission Public Schools, Mosley Public Schools, Leach Public School. All voted aye. Motion carried.

AGENDA #6- A motion was made by Steve Odle and seconded by Charles Marts to review/discuss the Delaware County estimate of Needs for Fiscal Year 24/25. The discussion went as follows: Barbara Barnes (Delaware County Clerk) stated that her office had sent the Estimates of Need in to Bill Turner. She said that when calculated, the Budget will be over by approximately 1,063,787.56. Doug Smith (Excise Board Chairman) asked to confirm, "so the Budget is over?" Barbara stated yes, but said that some changes were made and a special meeting will be needed to approve what everyone has turned in. Barbara said that we need to see what is required. Steve Odle (Excise Boad Member) asked Barbara what was amended. Barbara stated that some small changes were being made. Steve Odle asked about the increase from last year. Doug Smith stated "so, basically, we are not approving anything yet?" Doug also stated that the Board usually does this in October. It was agreed on by all the members of the Excise Board to hold a special meeting on 9-18-24 at 8:30am, to further discuss. All voted aye. Motion carried.

AGENDA #7 - A motion was made by Steve Odle and seconded by Charles Marts to discuss with possible action Sheriff Beck's budget; account balances, including both current balances and account balances on July 1, 2024; known payment obligations which are due on or before December 31, 2024; and requested employee pay raises in light of the 50% restriction included in 19 O.S. § 347C. The discussion went as follows: Doug Smith stated that a current Official that is leaving office on the last day of the year cannot exceed more that 50% of their Budget. He then asked Barbara Barnes (County Clerk) if that was correct. Barbara stated that was correct. She stated that we have the software for payroll, purchasing, and when calculated our numbers reflect that the Sheriff's budget will be over. She stated that the Sheriff does not agree. She stated that this has to go in front of the Excise Board for a decision, and that the numbers will need to be compared. Barbara stated that comp time and holiday time need to be considered as well. It was also said that vacation time between now and December accrues. Barbara stated that the Sheriff is proposing to have his calculations by Monday afternoon. Doug Smith said that the Sheriff can appeal any decision that is made. Steve Odle suggested that the DA should be at the Special Meeting next week. There was no further discussion, as this will be on the agenda for next week's special meeting. All voted aye. Motion carried.

AGENDA #8- A motion was made by Steve Odle and seconded by Charles Marts to hear citizen's participation/public comments. No public present. All voted aye. Motion not needed.

AGENDA #9 - A motion was made by Steve Odle and seconded by Charles Marts to adjourn the meeting at 8:56

am. All voted aye. Motion carried.
