Martin also said that the county is paying an avg of \$400 per month for the election board which includes, natural gas, electricity, water, sewer and pest control. Also, the county provides cleaning service. Martin said that if the county is not going to move the Election Board to the Courthouse as per recommendation by Homeland Security, the BOCC would need to remove the 4 election days from the holiday schedule.
