## **DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES**

## February 4, 2025

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on February 4, 2025. The agenda was posted February 3, 2025, at 8:30 a.m. and placed in the kiosk on the courthouse lawn as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Barbara Barnes. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. All members were present.

AGENDA #1 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to determine that notice of meeting and agenda for this meeting was properly posted in accordance with the Oklahoma Open Meeting Act. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #2-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve introductions and announcements. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. AGENDA #5 – A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve all monthly reports submitted by officers. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Reports were submitted by the Assessor, Health Department, County Clerk and Treasurer.

AGENDA #6 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck for approval of citizen's participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. January said voting for the Grove School election will be Thursday and Friday. Filing for school board candidates is this week. Rocky Carroll said the Eucha bridge is open to traffic again after a long construction project. He said in appreciation to the ODOT crews, his family will feed the crews at noon Friday and all the commissioners are invited. Carroll said the old bridge rail was donated to be used for his family cemetery.

AGENDA #7- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear a report from Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cossairt said two hires have been made since the last meeting. There have been no employee exits. The county has 140 employees today. She said two new employees start work today and one tomorrow. There are five county job position open. Two part-time jobs were termed. Cossairt said illness is rampant and many schools are closed. She stressed all employees should practice safety and cleanliness procedures to prevent sickness.

Cossairt reiterated that if an employee has an injury for which they need medical attention, the billing information given to the provider should NOT be the employee's personal medical card. The information must be for ACCO, so the bill will go there for workers' comp and not to the employee.

Cossairt said there is an outbreak of TB in Kansas. She said TB is airborne and all county employees are tested when they are hired. Detention officers are tested for TB annually.

Cossairt told the commissioners the reasonable suspicion training needs to be rescheduled.

AGENDA #8- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There was none.

AGENDA #9- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve a one-time transfer to pay back resale M&O from the temporary transfer completed on 10-30-24 in the amount of \$350,000 per Oklahoma Title 68, SS3021.4 on behalf of the County Treasurer. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There was none.

AGENDA #10- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action custodial position per Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cossairt said to clarify, this is not the contracted position. David McCord has that position and still plans to bid for a couple of more years. Hiring a part-time person paid hourly would be in case McCord is out. She said the posting is to try to find someone with the skill set or someone who can train for the skill set. A motion was made by Callihan and seconded by Beck to post the position. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Poindexter clarified this position would only be responsible for courthouse cleaning.

AGENDA #11- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve declaration of surplus of the following items on behalf of District 1: John Deere 7210 tractor, Inventory #D304-0110; John Deere 6145 M tractor, inventory #D304-0112; New Holland T4.110 tractor, inventory #D304-0111; John Deere 770 grader, inventory #D307-0119. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #12- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action estimate in the amount of \$12,910 from Carl Tesreau to upfit 2025 Chevrolet 3500 truck purchased for Emergency Management. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Reeves said this is the one ton truck the commissioners purchased to pull the mobile command trailer. Reeves said the grant has been approved in the amount of \$325,000 to purchase the trailer. He said the truck is at the Monkey Island Fire Department waiting on a bed. Callihan asked if any other bids were solicited. Reeves said no, that Tesreau has outfitted many other vehicles and he is meticulous with the work since he is a first responder himself. Donohue said Tesreau is a local provider, keeping the money in the county. A motion was made by Callihan and seconded by Beck to accept the estimate. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #13- A motion was made by Commissioner Callihan and seconded by Beck to approve a bid from Immer Mendoza in the amount of \$20 for Flint Ridge 1 Amended, Lot 32, Block 2, Fox Creek Area on behalf of the County Treasurer. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.
