

DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

April 12, 2022

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on April 12, 2022. Mike Major asked if the commissioners have had any communication with the state concerning the 911 audit. Poindexter said there is nothing new at this time.

AGENDA #5 - A motion was made by Commissioner Callihan and seconded by Conley Chesney (designee) to approve Hearing Human Resources Vicki Cossairt on current status regarding families first coronavirus and updates on other relevant topics managed by the Human Resources Director. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Conley Chesney (Designee)-yes. Motion carried.

Cossairt said the covid report is the same as the last few weeks. There are less than 10 active cases in both Delaware and Ottawa Counties. She suggested keeping an eye on the numbers through Easter and "if there are no spikes, let the pandemic end there in Delaware County. The risk is very low here." Cossairt suggests everyone get vaccinated and she said the disinfection procedures will continue in the courthouse. Concerning Human Resources, Cossairt said one detention officer, one dispatcher and one part-time dispatcher have started to work. Another detention officer and one patrol officer are "in the works," she said. Cossairt said jobs are open for a grader operator and seasonal employee in District #1 and an equipment operator in District #3. She welcomed Commissioner Beck.

Beck said he looks forward to working with the other commissioners and "hopes to make some improvements down south."

District Attorney Kenny Wright said Judge Denny is busy with a jury term so there are no new guidelines or modifications of old ones.
