

DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

April 29, 2025

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on April 29, 2025. The agenda was posted April 24, 2025, at 4:05 p.m. and placed in the kiosk on the courthouse lawn as well as the county website. Members of the Board present were Commissioner David Poindexter, Chairman, Commissioner David Beck-Member and County Clerk Barbara Barnes -Secretary. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Commissioner Poindexter followed by the flag salute and roll call. Commissioner Callihan was absent.
