

DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

July 12, 2022

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on July 12, 2022. The agenda was posted July 11, 2022 at 8:34 a.m. and placed in the kiosk located on the courthouse lawn as well as the county website. The meeting was called to order by Commissioner Callihan followed by the flag salute and roll call. Commissioner Poindexter was absent.

Parker reported B & B Heating & Air fixed the drainage problem from the air conditioner units on the roof Monday. This should stop the leak in the judges' chambers. Parker reported the drainage pipe covers and sump are full of wet leaves and algae and clogged. B & B will not clean or be responsible for the drains as they are a part of the building and not part of the AC units. Parker said in the past the janitor had the responsibility to keep the drains clean.

Motion carried. Cossairt said hydration is important in the intense heat. She said packets are distributed to the road crews which include Gatorade. She said there is a new Covid subvariant, but it is difficult to determine the number of cases because there is so much home testing. She said two cases in Oklahoma ended up in ICU. She reminded everyone to keep distancing, hand washing and using PPE when necessary.

Cossairt said Delaware County won the Outstanding Student in the North Region for the Cherokee Nation work program last summer. She said this summer Delaware County won the best work place award for the program.

AGENDA #13- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve payment of Application #1 for Delaware County Courthouse flooring project and estimate in the amount of \$19,400 to complete the project.

Callihan said he wants to return to the original contract where vinyl will be glued on all the courthouse floors because he believes it is the best material. He said water leaks are bad for the carpet squares many offices selected as per the May 31 meeting. Beck said he wanted to see prices for the carpet. The \$19,400 estimate listed in the item is the price of the carpet squares. "We are wasting money and there will be an additional cost to lay the 911 floor," Beck said. Beck said he has had phone calls about the carpet and "I don't know how it got out." The discussions and decisions about carpet squares are public record and recorded in the minutes Beck signed.

Callihan made a motion to pay the initial invoice in the amount of \$143,285.10 and go with the original contract of flooring. Beck seconded the motion.

Roll call: Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

The contract amount of the work completed, which is the invoice mentioned in the item is \$129,536.95. The amount in the motion, \$143,283.10, is the estimate for work to complete the project with the changes agreed to in the May 31 meeting.

AGENDA #14-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action space only for two employees to be paid by Comprehensive Opioid Stimulant and Substance Abuse Program Grant awarded to the Town of Jay from the Department of Justice. Employees will be getting people ready for drug court. Roll call: Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Callihan said he talked to the judges and there is a court reporter office that may be used to house the employees. He suggested the item to tabled until next week for confirmation. Beck agreed.

AGENDA #16-A motion was made by Commissioner Callihan and seconded Commissioner Beck to receive and file local election results on behalf of the County Election Board for the June 28 election. Roll call: Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #16-A motion was made by Commissioner Callihan and seconded Commissioner Beck to discuss with possible action allocating American Rescue Plan Act funds for rural water system requests. Roll call: Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

The county's ARPA attorney David Floyd said four requests were submitted from three entities by the July 5 deadline. He said he had spoken with West Siloam Springs, but the town did not submit a completed application. Floyd reminded the commissioners they budgeted one million dollars for infrastructure. Floyd said prior discussions had been to take the number of requests and divide the money equally. He said the commissioners might want to consider the fact that the Town of Jay received some ARPA funds of its own, so that might change the amount they decide to award. Callihan made a motion to award RWD #10 and the Town of Bernice \$250,000 each and wait for further direction on the other projects. Beck seconded the motion. Roll call: Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Floyd told the water representatives present he had paperwork for them to fill out accepting the award. As soon as those

papers are completed, the money can be allocated.

AGENDA #17-A motion was made by Commissioner Callihan and seconded Commissioner Beck to open the floor for new business. Roll call: Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Beck said there was a house fire at 3 a.m. Monday where a woman died. "A friend of mine lost her life. It really hits home and you really feel the need to get something going on this," Beck said. Beck said his son is a Colcord Deputy and a firefighter and he was unable to get any response from calling 911. Beck said his son could not make radio contact with the county the day before. Sheriff Beck said Grove might have been the primary dispatch during the fire. Emergency Manager Jeff Reeves confirmed the dispatch would have been from Jay. Callihan said the dispatch situation is "very critical."

Reeves said he is in the process of getting bids for new equipment, but the bid package is very large. He understands it is urgent to get the bids. He said it is critical to have good communications, but because the distances are sometimes large and it takes a while to answer calls. "I understand the system went down yesterday." Reeves said there was apparently a big traffic accident and no 911 communications was possible.

"I know at three o'clock in the morning everybody's in bed," Commissioner Beck said.

Sheriff Beck said the 911 center is a mess and invited the commissioners to come look at the situation. He said there are so many wires under the desks no one can figure them out and the furniture is so worn it snags the workers' clothing.

AGENDA #18-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to adjourn at 9:37 a.m. Roll call: Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.
