

DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

September 23, 2025

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on September 23, 2025. The agenda was posted Sept. 22, 2025, at 8:45 a.m. and placed in the kiosk on the courthouse lawn as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Barbara Barnes. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. All members were present.

AGENDA #1 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to determine that notice of meeting and agenda for this meeting was properly posted in accordance with the Oklahoma Open Meeting Act. AGENDA #6 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck for approval of citizen's participation or comments. All comments must pertain to today's agenda items. Speakers should hold their comments to three minutes. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #7- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear report by Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cossairt said the county has 135 employees today. Since last week, there have been two terminations, and one new hire. Seven positions are posted for county employment with five actually open, all in the Sheriff's Office.

The county's first CDL class is complete. Two people have passed the driving test and got their Class A CDLs, three are scheduled to test and one must be scheduled to test. Cossairt said potential employees with a Class A CDL license are difficult to find, so the county is now doing its own testing to make CDL drivers. She said this is a big deal for the county. The second class will begin in October.

Cossairt said employees with flu symptoms should be encouraged to stay home.

Cossairt said annual medical DOT physicals to keep CDL licenses current are coming up and the county will get them for the drivers.

Cossairt said Oct. 1 is supposed to be the start of insurance option period. American Fidelity will have a representative here Sept. 29 to present their extra insurance products to any employees who are interested.

AGENDA #8- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There was none.

AGENDA #9- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to sign payroll affidavits for the Sept. 30 payroll. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #10- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to set additional pay date of Nov. 20, 2025, to pay longevity payments to county staff. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes.

Motion carried.

AGENDA #11- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action contract with Air Wise Heating and Air for preventative maintenance from Oct. 1 through Sept. 30, 2026, in the amount of \$4,510.80. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Barnes confirmed the price is the same as last year. The commissioners agreed they are happy with the service and prompt attention if they call for help. A motion was made by Callihan and seconded by Beck to approve the contract. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #12- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve an intrafund transfer from Monkey Island Fire lease/purchase to Monkey Island M&O in the amount of \$30,000 per Fire Chief Carl Tesreau. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #13- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open sealed bids regarding chip and seal application for Delaware Couty District #2 with possible acceptance. Co. Bid #25-26/01. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There was one bid from Asphalt Paving & Building. The quotes were on two different thicknesses of application and with two different kinds of oil: .325 application rate at \$135,842 and \$139,898 and .425 application rate at \$154,229 and \$160,102. Commissioner Callihan took the bids under advisement.

AGENDA #14- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open sealed bids regarding bridge rehabilitation for Delaware County District #3 with possible acceptance. Co. Bid #25-26/02. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There were no bids.

AGENDA #15- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action hiring lawn service for courthouse and storage building. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. No action was taken.

AGENDA #16- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to sign memorandum of agreement with Cherokee Nation to improve bridge #35 in District 1. Project #JP-30482(04). Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes;

and Commissioner Beck-yes. Motion carried. Poindexter said this is a new approach to bridge rehabilitation. Cherokee Nation will take on some of the bridge projects from the county's five-year plan. This one is east of Butler Fire Department on Stand Waite Road. Poindexter said thanks to Cherokee Nation, this is a fast forward. This program moves the project up four years.

AGENDA #17- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve a donation project to pave Pecan Street in Crace Shores in the amount of \$21,754.54 per Commissioner Poindexter. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #18- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action plans for the old fairgrounds per Commissioner Callihan. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Callihan said he would like to move his District 2 operation there. His current barn is in the Jay school zone and he said this is dangerous for students and his employees alike. In addition, he said he is needing more office space and the old fair building has plenty. It would also get his barn out of town. Beck asked about selling the property. The other commissioners agreed this is an option. Sheriff Thomas said he wants a maintenance barn and District 2's current location could serve that purpose as well as an impound lot. The commissioners agreed to explore the idea further.

AGENDA #19- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action proposal to replace windows, doors, and painting in Delaware County School House at an estimated price of \$42,000. Callihan said Absolute Roofing did such a good job that the leaky or missing doors and windows should be replaced. He said the item might need to be bid or at least get some phone quotes. He asked Barnes to get some bid specs together. Pewitt said the bond requirement for the job still applies. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #20- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to adjourn the meeting at 9:34 a.m. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.
