

DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

December 9, 2024

The Board of County Commissioners of Delaware County met in Special Session at 8:30 a.m. on December 9, 2024. The agenda was posted December 5, 2024, at 8:00 a.m. and placed in the kiosk on the courthouse lawn as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Barbara Barnes -Secretary. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. All members were present.

AGENDA #1 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to determine that notice of meeting and agenda for this meeting was properly posted in accordance with the Oklahoma Open Meeting Act. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #2- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve the minutes for the regular meeting dated December 3, 2024. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #3- Was not needed.

AGENDA #4- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss the acknowledgement of the resignation of Sheriff James Beck. The resignation will be delivered to the County Clerk. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Poindexter said the resignation, which is dated Dec. 2, will be delivered to the County Clerk.

AGENDA #5- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action the appointment of an interim Sheriff in accordance with Oklahoma State Statutes 51-9 and 51-10 to fill the remaining term of Sheriff James Beck. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. A motion was made by Callihan and seconded by Beck to appoint Ray Thomas as interim Sheriff. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Thomas was sworn in by Judge David Crutchfield.

AGENDA #15- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to adjourn at 8:43 a.m. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.
