The place and address of the meeting will be at the Delaware County Election Board Office at 225 S 5<sup>th</sup> Street, Jay, OK.

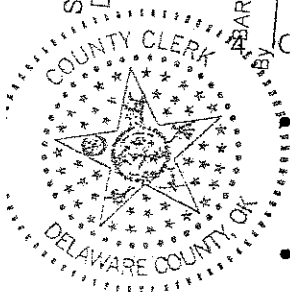
